# Proposed Action by Board of Education

Approve the attached annual renewal of the State of Illinois School Treasurer Bond in the amount of \$13,000,000.00.

## Background

The Illinois School Code requires each school district maintain a treasurer's bond at a level of 25% of the total district funds in the treasurer's custody at any given time. The bond is adjusted periodically based on cash balances. The bond renewal is approved annually although the bond is notarized and executed when first issued, and thereafter only if the insurance carrier changes, or there is a new business manager.

Attached is the annual invoice and executed bond form renewal of the treasurer bond issued through Liberty Mutual Surety (The Ohio Casualty Insurance Company). The term of the bond is September 1, 2016 through September 1, 2017.
